Project 2025 "Mandate for Leadership" Page Numbers Full List

There are many Project 2025 summaries, explainers, and articles available now. Most of them are text-based, very general, and lack page numbers. There are also a lot of claims about Project 2025 floating around on social media, some accurate, some not. What distinguishes this resource is that it is visual, it is more comprehensive, and it provides page numbers. In a series of infographics I break down each of the primary goals into a concept map with page numbers. There is also a text compilation of all the page numbers shown on the maps (see below). My intent was to bring the receipts and create a resource that will enable you to look up exactly what the Project 2025 document says about an issue. Now when someone says, "Oh no, Project 2025 doesn't say that," you can easily look it up.

A couple of things struck me as I worked thorough this material. Even though I keep informed, spending hours looking at the sheer mass of ill will the MAGA Republicans bear toward their fellow Americans was emotionally challenging. I was also amazed by their absolute determination to stamp out any speech about social justice. Invective against "wokeness," "gender ideology," and so forth pervades every section of the document. I guess I can still be shocked. But it also tells us we're doing something right and we should keep on talking about social justice and pushing our institutions make a fair world for all of us.

Is this resource comprehensive? No. It provides a great deal more detail than any other resource I've seen, but the document is 920 pages long (I downloaded the PDF from the Harris-Walz campaign site). It contains a mind-numbing mass of detail, much of it drily describing the workings of government. Did I read it cover to cover? Good heavens, no. The Heritage Foundations' strategy seems to be to flood the zone with details in a document no sane person would spend their time reading. I researched specific topics and terms, trying evaluate and synthesize the intentions and plans of the "next conservative Administration." It was no small task to winnow down the mass of information into some form that approaches accessible and digestible. It seemed like every time I looked at the document I saw something else alarming.

I am positive that everyone who looks at this is going to say, "Yes, but what about...?" Please email <u>MomentumBlueSeattle@gmail.com</u> about any typos, omissions, or inaccuracies. If Trump is elected it will be a roadmap to what his administration is going to try to do.
